

TERMS & CONDITIONS FOR USE

1. Information regarding how to download content available at the 'Mobile' microsite (**Mobile Content**) of uniform resource locator www.pogo.tv (**Website**) on web-enabled mobile phones form a part of these terms & conditions for use (**Terms**).
2. Mobile Content is available, for download, to all legal residents of India who are of 18 years of age or above the age of 18 years as on the date of download (each an **End User** and collectively **End Users**). In case the End User is below the age of 18, he or she must seek parental or guardian approval before downloading the Mobile Content from the Website. It will be the responsibility of parents or guardians to monitor their children's activity while downloading Mobile Content from the Website.
3. End Users may download the Mobile Content via logging on to the Website and clicking on the "Mobile" microsite. End Users can then choose from the variety of downloadable Mobile Content available and to download, be required to send text using short message services (**SMS**) in such form and to such number as may be provided along with such Mobile Content. The End Users will then receive a text providing them with the web link, by clicking on which the Mobile Content will get downloaded on the mobile phone of the End User through WAP push service. To download the Game, End Users shall only use web enabled phones available in India using any of the following networks: Airtel, Vodafone, BSNL (excluding BSNL East), Idea, BPL, MTNL Delhi, MTNL Mumbai and Aircel.
4. End Users will be solely responsible for all charges incurred in downloading the Mobile Content, including any telephone, internet usage and, or mobile phone charges. Each SMS sent by an End User will cost him or her maximum amount of Rs. 3.00/- (Rupees Three) per SMS, inclusive of any applicable mobile phone operator charge, and any applicable taxes, levies or duties. The Mobile Content will be available for download at a cost which may vary depending upon the mobile operator and handset used (**Cost of Download**). The Cost of Download will be directly deducted by the mobile operator in case of a pre-paid user or will be billed in the monthly bill in case of a post paid user. Any discrepancy in such deductions, billing or failure to download the Mobile Content for reasons not limited to insufficient balance shall not be the responsibility of the Promoter (as defined in paragraph 11 below). These Terms shall not waive any terms that the End User may have entered into with the mobile operator. By submitting their mobile number or sending the SMS as mentioned above, End Users accept these Terms.
5. The Promoter is not responsible for the service and support of the Mobile Content after it has been downloaded by the End Users.
6. End Users' personal information (**PI**) may be collected to enable them to download the Mobile Content to their mobile phone through WAP push services. The PI of End Users may be provided to others assisting the Promoter in this regard, Promoter's affiliates, partners and government authorities if required.
7. All intellectual property rights in the Mobile Content shall vest perpetually with the Promoter. By downloading the Mobile Content, each End User consents to the information submitted with their entry being entered into a database and to the use by the Promoter and, or its affiliates of this information in any media in accordance with the Promoter's online privacy policy <http://pogo.tv/privacy-policy> for future promotional, marketing and publicity purposes without any further reference or payment or other compensation to the End User. All personal details (including the PI) of the End Users will be stored at the office of the Promoter in accordance with

the Promoter's online privacy policy. Any request to access, update or correct any information should be directed to the Promoter at the address as listed below.

8. To the extent permitted by law, the Promoter makes no representations or warranties as to the quality, suitability or merchantability of the Mobile Content. To the extent permitted by law, the Promoter shall not be liable for any loss or damage whatsoever that may be suffered, or for any personal injury that may be suffered, as a result of downloading the Mobile Content or using the Mobile Content.
9. The Promoter reserves the right in its sole discretion to cancel, terminate, modify or suspend any available Mobile Content if, for any reason, it is not capable of functioning as planned, including but not limited to reasons of infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of Promoter that corrupt or affect the administration security, fairness, integrity or proper conduct of the Mobile Content. End-Users shall not transmit, modify, distribute, exhibit, duplicate, copy, store, record, sub-licence or otherwise misuse the Mobile Content or any portion of it by any means. End-Users shall not copy and forward the Mobile Content to third parties and shall not receive the Mobile Content while roaming outside India.
10. The Promoter assumes no responsibility for any error, omission, interruption, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of, entries. The Promoter also does not accept the responsibility for any delays in relation to download of the Mobile Content. The Promoter shall not be responsible for any problems or technical malfunction of any mobile network, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail to be received by the Promoter, including any injury or damage to any End User's or any other person's mobile related to or resulting from downloading any materials in or in connection with this Game. **CAUTION:** any attempt to deliberately damage any website or the information on a website, or to otherwise undermine the legitimate operation of this Competition may be a violation of criminal and civil laws and should such an attempt be made, whether successful or not, Turner and the Promoter reserves the right to seek damages to the fullest extent permitted by law.
